THREE NEW PROGRAMMES IN BINGHAM UNI

The National Universities Commission (NUC) has approved the establishment of three new programmes in Bingham University. The programmes that got the approval are Law (LLB) to be run under the new Faculty of Law, Nursing (B. NSc) under the Faculty of Health Sciences and Pharmacy (B. Pharm) under the Faculty of Pharmaceutical Sciences.

The approval follows the resource evaluation visit to the University in February 2018 by panels of experts from the NUC to assess the human and material resources available for the establishment of the listed programmes.

A letter conveying the Commission's approval to the Vice-Chancellor of the University and signed by Dr. G. B. Kumo, the NUC Director of Academic Planning on behalf of the Executive Secretary, directed that the programmes should commence effective from the 2017/2018 academic session. The letter further stated that the programmes should be run in the main campus of the University on a full-time basis.





TRUSTEE DR. PHILIP USMAN LAID TO REST

Thousands of sympathizers from all walks converged in Dass, Tafawa Balewa Local Government Areaof Bauchi State to bid farewell to Dr. Philip Usman, an ECWA trustee who died on the 4 t h February, 2018.

Bauchi State Governor, Barr. Mohammed Abdullahi Abubakar, in a condolence message, described the late Dr. Usman as a person who served the state faithfully when he was Commissioner of Finance during which no traces of corruption or financial misappropriation were found against him.

Represented by the Commissioner of Environment, Mrs. Rifkatu Samson Danna, the Governor said that the deceased would be greatly missed in times like this when government was fighting corruption.

He appealed to ECWA and the people of the State to be comforted by the fact that he had left a legacy worthy of emulation which would continue to speak for him even after his death.

The ECWA President, Rev. Dr. Jeremiah Gado, likened Dr. Usman to the children of Isaccah in the Bible who stood the test of time and overcame it.

According to him, the late trustee was a trophy of God's grace given to the Church who served diligently and gave his best for the gospel of Jesus Christ, adding that he always put the work

of God first before any other thing, as a result of which he turned down lucrative appointments and public service positions to remain in the vineyard of the Lord.

He noted that Trustee Philip Usman would be remembered for his great contributions to ECWA and the growth of the church in Nigeria in general, adding that the church would continue to use the legacies he left behind to the glory of God and humanity.

On his part, the Emir of Dass, Alhaji Usman Bilyaminu Othman the 2nd, stated that the deceased was a complete gentleman, peace maker and bridge-builder who was very instrumental to the peaceful co-existence Dass had enjoyed over the years, adding that the community would greatly miss his wise counsel and prayed for God to provide another humble leader like him who would continue from where he stopped.

In a message, ECWA Assistant General Secretary, Rev. Dr. Eliazar Baba, said that death was a necessary end for every soul that lived on this earth before Christ's return and urged Christians not to mourn like those who do not have hope.

Speaking on the topic, Why do the righteous die? He took his text from Isaiah 57:1-2 and stressed that, just like the time of the Israelites where people were engaging in witch-craft, rape, corruption and such other acts, that was the time God decided to take the righteous home and wondered why that was so.

Until his death trustee Usman was also a member Bingham University Board of Trustees.
